### Product Data

#### 1. Product Description

The 3M Plastic Pipe Device is a one piece metal collar assembly encasing 3M's heat expanding 3M™ Interam™ Ultra GS (intumescent) material. Manufactured with 3M's firestop technology, it has been contract or designed and UL Classified.

The 3M Plastic Pipe Device is used for new and retrofit installations and will accommodate 12 inch (38 mm) 2 inch (5 cm), 3 inch (7 cm) and 4 inch (10 cm) schedule 40 drain, waste and vent pipe systems. The 3M Plastic Pipe Device achieved up to 3 hour fire ratings when tested by Underwriters Laboratories, Inc. in accordance with ASTM E 814 (UL1479)

#### 2. Applications

The 3M Ultra PPD is used to seal ccPVC, PVC, CPVC, FRPP, PVDF, ccABS and ABS pipes penetrating 1 and 2 hour floor/ceiling assemblies and 1, 2 and 3 hour fire rated gypsum wall-board assemblies and up to 3 hour fire rated concrete wall, floor or hollow core assemblies.

It may be applied to drain, waste and vent or closed pipe systems. See manufacturer's instruction sheet supplied with each device for exact types of plastic pipe covered and hourly ratings.

#### 3. Physical Properties

#### 4. Specifications

Installations shall be in strict accordance with manufacturer's written instructions, as shown on approved shop drawings.

The device shall also be classified by Underwriter's Laboratory Inc. as a through-penetration firestop device when tested in accordance with ASTM E 814 (UL 1479) for up to 3 hour rating.

All penetrations must be firestopped with a UL Classified system or device as listed in current UL Fire Resistance Directory or have approved shop drawing prior to installation.

Suitability for the intended service application should be determined prior to installation.

3M Fire Barrier Plastic Pipe Devices are available from Authorized 3M Fire Protection Products Distributors.

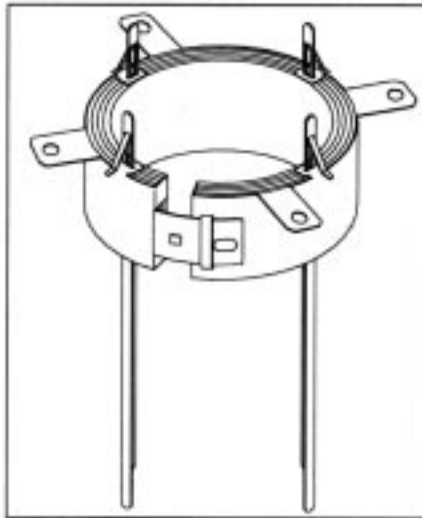


Figure 1: PPD & Ultra Fast Anchor

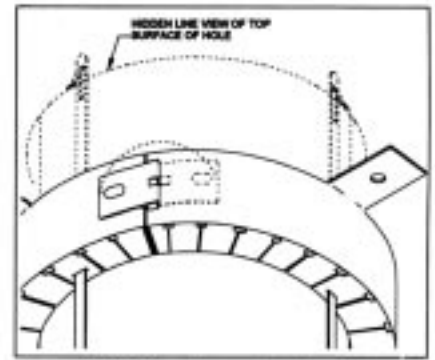


Figure 2: PPD positioned and anchor straps inserted

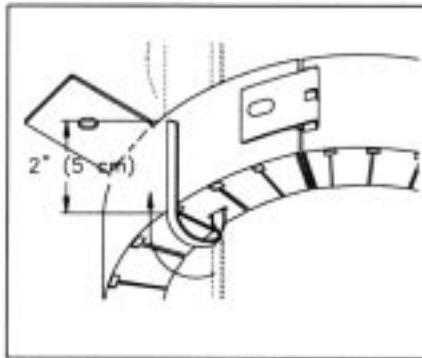


Figure 3: Ultra Fast Anchor Strap and PPD secured and locked into position.

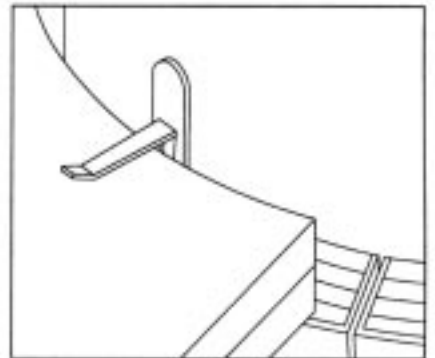


Figure 4: Top view of Ultra Fast Anchor Strap in place after installation complete.
