To determine whether the mattress ticking treated with BURN BARRIERTM FPC Flame Retardant meets the NFPA (National Fire Protective Association) Test No. 701, Standard Methods of Fire Tests for Flame-Resistant Textiles and Films.

Procedure:

The submitted rayon mattress ticking was sprayed (while hanging) with the BURN BARRIERTM FPC Flame Retardant until the entire sample was moist to the touch. After drying the sample was tested per the NFPA No. 701 test, Vertical-Small Scale Test.

Test Criteria:

After flame - 2 seconds maximum Length of Char - 41/2 inch maximum
